Enclosed is the formal notice, pursuant to the Worker Adjustment and Retraining Notification Act of 1988 and related state and local laws (collectively, "WARN"), relating to the potential plant closing (each as defined by WARN) by The Great Atlantic and Pacific Tea Company, Inc. at the store and/or facility locations listed on the attached notice.

We provide this notice on a contingent basis. On July 19, 2015, The Great Atlantic and Pacific Tea Company, Inc. and its direct and indirect subsidiaries (collectively, the "Company") filed voluntary chapter 11 petitions for relief in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court"). As part of the chapter 11 process, the Company is engaging in a sale process through which it is seeking to sell all of its store locations. The Company already has signed contracts to sell 120 stores, subject to Bankruptcy Court approval, identified on the attached **Exhibit A**; and the Company is actively marketing all the stores identified on **Exhibit B**. In the event an employee does not receive an offer of employment from a purchaser of one of the Company's stores, we expect that their job loss would occur during the two week period from November 12, 2015 to November 26, 2015.

The information, referral and counseling provided by the response team will address available public programs which make it possible to delay or prevent the transfer or termination of operations, including economic development incentive and workforce development programs, public programs or benefits which may be available to assist the employees, including but not limited to, unemployment compensation benefits, job training or retraining programs, and job search assistance; and employee rights based on P.L. 2007, c.212, or any other law which applies to the employees with respect to wages, severance pay, benefits, pensions or other terms of employment as they relate to the termination of employment.

Employers covered by P.L. 2007, c.212 are required to provide the response team with the amount of on-site work-time access to the employees of the establishment that the response team determines is necessary for the response team to carry out its responsibilities under the law.
